The names of all eligible applicants for membership shall be referred to the Membership Committee for processing. Applicants determined by the Membership Committee to meet applicable requirements and standards for membership, and other applicable laws, regulations, rules, policies, and procedures, shall be referred to the Board of Trustees for consideration at its next regularly scheduled meeting.

The Board of Trustees reserves the right to deny membership to any applicant who does not meet the legal requirements and standards noted above and expected of all members. Upon being appointed as a member in any of the categories listed in Article III, Section 1, a member automatically becomes part of the Active Membership.

Membership Dues Upon appointment, an Active Member shall be required to pay membership dues in the amount of twenty-five dollars (\$25.00) annually. In addition, annually, at the first Membership Meeting of the PCSPCA held during the calendar year, each Active Member must pay membership dues of twenty-five dollars (\$25.00).

Upon appointment, a Junior Member shall be required to pay dues in the amount of ten dollars (\$10.00). In addition, annually, at the first Membership Meeting of the PCSPCA held during the calendar year, each Junior Member must pay membership dues of ten dollars (\$10.00). Any Junior Member who fails to pay initial or annual dues sixty (60) days after they are due shall be considered suspended from Junior Membership and not in good standing. In order to be reinstated to good standing, a Junior Member must pay any dues owed and be voted back into good standing by the Board of Trustees.

Rights of Members in accordance with the provisions of these Bylaws, as well as relevant laws, regulations, rules, policies, and procedures, Active Members in good standing shall have the right to: Attend Membership Meetings and be appointed to committees. Vote in an election for a Trustee of the Board of Trustees, provided they are up to date on dues, attended a minimum of seventy-five percent (75%) of monthly meetings within the previous twelve (12) months leading up to the election or has volunteered in at least one event per calendar quarter and/or has achieved a combination of the previous three at the discretion of the board of directors.
