The Passaic County Society for the Prevention of Cruelty to Animals is a non-profit, all volunteer, humane education and advocacy group. Operating since the 1890s, Passaic County SPCA is the ONLY agency in the county that focuses solely on the prevention of animal cruelty and neglect.

I. Accomplishments

Pivoted all operations to meet COVID-19 pandemic requirements

Pantry

- More than doubled number of families served—from 21 to 44 total as of 12/31/2020
- Distributed pet food, including:

- Opened pantry 15 times for food distribution

- Provided hundreds of pounds of open and expired pet food to local wildlife rehab groups
- Collected donations, and assembled and distributed holiday packages to roughly 20 active pantry clients at December pantry
- Repaired and rebranded van
- Initiated partnership with Martha's Pantry at St. Clement's Church

- Assisted in a clean out and set up of trailer

- Conducted Pictures with Santa on HQ porch (12/19/20)
- Named our first annual Member of the Year Peggy Faller



Advocacy

- Prepared and sent letters to state elected officials supporting two separate pieces of New Jersey State Legislation, including:
 - ✓ **Bill No. S930** to ensure that animals involved in divorce cases or dissolution of civil unions would be issued protection orders and assignment of pet custody.
 - ✓ *Bill No. A1909*, also known as "*Brianna's Law,*" would protect our animals by prohibiting the transport and slaughter of pregnant livestock in New Jersey, making it a Crime of the 4th Degree during their gestation period.
